INSTRUCTIONS

All fields marked **REQUIRED** must be filled out completely.

1. Name of corporation-**REQUIRED**: Please provide the complete name of the corporation, as it appeared on the records of the Secretary of the State. If the name is no longer available, please complete and file Articles of Amendment, along with the Certificate of Reinstatement, changing the name of the corporation to an available name. (Please see Amendment Form for additional filing fee).
2. Appointment of agent for process-**REQUIRED**: THE CORPORATION MAY NOT BE ITS OWN AGENT. Must appoint an individual or entity (other than this entity) to accept legal process, notice or demand served upon the corporation. The agent may be **EITHER**:
 - a. Any individual who is a resident of Connecticut.
 - An individual must provide the complete street address of his or her business and a Connecticut residence address. (If no business address, must state "None").
 - The agent must sign accepting the appointment.
 - or*
 - b. One of the following business types, on record with this office, with a Connecticut address:
 - A Connecticut corporation, limited liability company, limited liability partnership or statutory trust.
 - A foreign corporation, limited liability company, limited liability partnership or statutory trust, which has obtained a certificate of authority to transact business in Connecticut and has a Connecticut address on file with this office.
 - Provide the Connecticut principal office address in the block designated for "Business address". The agent must sign accepting the appointment and the person signing on behalf of a business must print his/her name and title next to his/her signature.
3. Execution-**REQUIRED**: The person executing this document must print or type his or her full legal name and provide a signature. Note that the execution is made under the penalties of false statement, certifying that the information provided in the document is true.
